

<u>DEPOT 125 CAPITAL CAMPAIGN</u> <u>SECOND HALF 2016 GIFT REPORT</u>

Shortly after the July 1, 2016 125th anniversary of the opening of Keokuk Union Depot, the Jeffris Family Foundation paid the \$333,000 that it had granted to the Keokuk Union Depot Foundation ("KUDF") in 2014. The KUDF raised the required \$667,000 match more than a year before the deadline.

During the second half of 2016, donors gave \$98,828 to the Depot 125 Capital Campaign. Together with the Jeffris grant, contributions made between July 1 and December 31, 2016 reached \$431,828, for a grand total of \$1,021,828 since the beginning of the Capital Campaign on June 18, 2014.

KUDF has set the capital campaign goal for completion of the roof restoration at \$1,250,000, with the same target date as the original Jeffris match deadline, September 30, 2017. This will cover the cost of completing the tiling of the upstream and downstream ends of the roof in 2017 and all the enhancements that have been added since the original plans were done three years ago.

THROUGH MARCH 31, 2017, GIFTS AND PLEDGES FOR THE DEPOT 125 CAPITAL CAMPAIGN TOTAL \$1,086,244, LEAVING \$163,756 TO BE RAISED TO COMPLETE THE ROOF. In early April we received a \$5,000 grant from the National Trust for Historic Preservation!
